



Fort McHenry's Role in WWI & More! Ranger Vince Vaise

Maryland Bell Ringing - Excerpts: MD Dept. of Veterans' Affairs Press Release 8 Aug 2018

Maryland Gov Larry Hogan issued a proclamation calling for bells to be tolled in Maryland on November 11, 2018 at 11:00 am in remembrance of veterans of World War I. The proclamation coincides with a call by the United States World War I Centennial Commission for all Americans to participate in a national tolling of bells. "Over 62,000 Marylanders served honorably during World War I, making incredible sacrifices to bring justice and freedom to all people," - Governor Hogan.

Sunday, November 11, 2018 marks the 100th anniversary of the signing of the Armistice which ended World War I. 62,000 Marylanders served in World War I, including 11,000 African Americans and 6,000 women. Nearly 2,000 gave the ultimate sacrifice.

Marylanders are asked to toll the bells twenty-one times with a five-second interval between tolls beginning at 11:00 am on Sunday, November 11, 2018 in commemoration of the armistice. Organizations, towns, churches and museums across the state will also participate.

The action of tolling the bells has historical significance as a signal indicating the end of World War I. During WWI, all church bells were silenced only to ring as a warning of invasion by enemy troops.

8th Annual Congressional Luncheon

The 8th Annual Congressional Luncheon was held on 26 September in the Dirksen Senate Office Building in Washington DC. Both US Senators (Ben Cardin and Chris Van Hollen) and eight of the ten US Representatives (Andy Harris, Dutch Ruppersberger, John Sarbanes, Steny Hoyer, John Delaney, and Jamie Raskin) spoke to the audience. MOAA President Lt Gen Dana Atkins, USAF (Ret), and 22 members of the MOAA staff attended. President Tom Seybold and his wife Karen and John and Evelyn Baesch represented the Chapter. Tom introduced Representative Dutch Ruppersberger from the 2nd District. He also had a chance to chat with LTG Atkins about our successful paws4vets Fundraiser. Gen. Atkins mentioned it to the assembled MD Chapter Presidents, Council and MOAA staff.

Some of the legislators' comments reported by Laural Hobbes, MOAA Senior Editor:

"It's a great privilege to hear the stories of veterans and think about the things I can do as a legislator to help [you]," Rep. John Delaney (D-Md.) told the assembled group of Maryland chapter members. "Most of the legislation I've done related to veterans came from stories I heard from them."

Rep. John Sarbanes (D-Md.) implored chapter members to continue advocating for servicemembers and veterans. "[Advocacy] is more important now than it's ever been because there are more fiscal constraints,"

The widows tax was just one of the issues Rep. Andy Harris (R-Md.), a veteran of the Navy Reserve, vowed to work on: He also identified <u>Chapter 61 retirees</u> and the necessity of ensuring the fitness of those who enter military service by offering competitive recruiting packages. "We need to make the determination," Harris said. "Which is more important: a force we know is mentally and physically capable, or hitting a number?"

Multiple representatives discussed the importance of funding a strong military, especially in light of national security threats. "We need to stand strong, and it's the men and women of our military who are standing there," said Rep. Ben Cardin (D-Md.).

Rep. Dutch Ruppersberger (D-Md.), co-chair of the House Army Caucus, identified funding future weapons as a top priority. "We have to make sure we work and put in the money for the future and future weapons that Russia and China are also developing," he said, while calling for veterans to get the medical care they deserve, fair disability compensation, benefits reflective of honorable service, and a responsive VA.

"Russia impacted our elections," said Rep. Steny Hoyer, minority whip. "That's a threat to our basic democracy. But if we invest directly in cybersecurity, we can compete with anyone in the world."

Sen. Chris Van Hollen (D-Md.) echoed Hoyer's message on the importance of cybersecurity. He also detailed wins for veterans in Maryland. "We made it a priority to mass the VA and military construction appropriations signed into law by the president a few days ago," he said.

UPDATE FOR MEMBERS, SPOUSES AND SURVIVING SPOUSES:

FEDVIP is Coming for Dental and Vision Coverage in CY 2019. The June-September issue of Army Echoes (the official Army newsletter for retired soldiers, surviving spouses, and families), shares the fact that "beginning with the 2018 Federal Benefits Open Season (Nov. 12 to Dec. 10, 2018), beneficiaries enrolled in a TRICARE health plan will be eligible to enroll in the Federal Employees Dental and Vision Insurance Program (FEDVIP). Coverage will start Jan. 1, 2019." So, those of us who are enrolled or are eligible to enroll in the TRICARE Retiree Dental Program will be able to select from several dental options for 2019. There are expected to be a total of 10 dental plus four vision carrier options. Delta Dental will be one of the ten. Everyone is advised that enrollment is not automatic--and that is even if you currently are enrolled in the TRDP plan. It also is important to understand that benefits and costs are susceptible to adjustment each year. In summary, while all the details of your options are not yet available, almost all TRICARE beneficiaries will be eligible to sign up during the open season coming this fall. The TRICARE Retiree Dental Program will end at the close of this calendar year. FEDVIP already has a website for additional information and to sign up for notifications about the upcoming changes: https://tricare.benefeds.com Future updates to the website are expected to include (a) educational webinars, (b) premium payment information, (c) 2019 FEDVIP plans and rates, and (d) FEDVIP carriers' and OPM contact information. By the way, according to the Centers for Disease Control and Prevention (CDC), regular eye exams are key in keeping one's vision strong, diagnosing potential issues early, and preventing diseases that may lead to vision loss or even blindness.
